J U D G M E N T

MASTER COOK:

- 1 On 5 October 2021 Master Davidson made an interim third party debt order, the third party being Payward Ltd. The judgment creditor was the benefit of a money judgment in the sum of £2,935,204.30.
 - 2 I have read the witness statement of Mr Syedur Rahman, who states that on 10 November 2021 the order of Master Davidson was served upon the third party together with a covering letter explaining the background. At para.8 of her witness statement she states that there has been no response from Miriam Core and in those circumstances, it seems to me, I can be satisfied that the third party is properly on notice of this hearing.
 - 3 I am now asked to make the interim order made by Master Davidson final. Having regard to the matters that have been put in evidence before me, I am satisfied that the debt is outstanding to the judgment creditor, that there is a debt payable from the third party to the defendants, and that in those circumstances the applicants are entitled to have the interim order made final.
 - 4 I will make that order final in terms of the draft and to that I will add the usual fixed costs, which will be added to the judgment debt.
