2. In these two suits, a total of four patents have been asserted which are as under:

- IN300066 (SEP)
- IN269929 (SEP)
- IN321300 (SEP)
- IN259932 (Non-SEP)

3. Out of the above four patents, three are SEPs and one is a non-SEP. Submissions have been addressed only in respect of two of the patents being IN259932 and IN300066. These two patents have also been asserted in the ***CS(COMM) 303/2021 & CS(COMM) 304/2021*** matters where the Id. Division Bench has directed a *pro tem* measure which has also been upheld by the Supreme Court and the deposit has been made by the Defendants in the said suits.

4. Since the patents asserted are the same, let Id. Counsel for the Defendants seek time to seek instructions as to whether Defendants are willing to deposit the last paid amount in terms of the previous license which was executed with Nokia which expired on 31st December, 2021 and whether the India component can be deposited in this Court.

5. In view of the order passed today, in the present suit as also in



***CS(COMM) 303/2021 & CS(COMM) 304/2021***, the judgment in the interim injunction application shall not be treated as reserved at this stage and is de-reserved.
