### Overview

The National Board of Trade is the government agency dealing with foreign trade and trade policy.

The board provides the Swedish government with analyses and input on trade policy matters. The board also has the mission to increase public knowledge about these issues. Another important role is that of being a contact and enquiry point for business and citizens, both for problem solving and for information in different areas.

The overall objective is to promote open and free trade with transparent rules. The National

Board of Trade works for an effective internal market, an open trade policy in the EU, and a strengthened multilateral trading system within the WTO framework. Sustainable development is an integrated aspect of the board's work.

The board acts as ombudsman for free trade and free movement within the EU, as a partner of the SOLVIT network. Open Trade Gate Sweden, with the purpose of aiding businesses in developing countries to export to Sweden, can also be found at the board.
